HEALTH & SAFETY – All risk assessments and valid public liability insurance certificates must be provided, as required, no later than 7 days prior to the event. Failure to provide the required documentation may result in cancellation of trade space booking with no refund. You are required by law to take out the necessary insurance against fire and all other risks including third party claims. The exhibitor must also indemnify RN Events Ltd against all damages, claims or expenses whatsoever in any way arising out of his attendance or his exhibits on the event site. Your signature on the booking form shall be deemed as confirmation of this.

Sub-Letting – You are not permitted to share stands.

STAND CLEANING – You are responsible for the cleanliness of your stands/display, rubbish must be removed daily and the area regularly checked for hazards. Additional cleaning costs will be passed onto the exhibitor.

ELECTRICITY – If electricity is not pre-booked 7 days prior to the event a 25% levy will be applicable. All electrical equipment must carry a Portable Appliance Testing Label. Outdoor Traders who have provided their own electrical supply must have generators fit for purpose, they should have suitable earthing arrangements either by spike or earthing plate. RN Events Ltd reserve the right to prevent the use of a system it does not consider safe. Marquees – Stand marquees must be fit for purpose including adverse weather conditions. Risk assessments must be carried out and RN events Ltd reserve the right to prevent the use of a marquee it does not consider safe. Security – You are responsible for the safe-keeping of your own stand, although we do have security on hand for the entire event. Right OF ADMISSION – RN Events Ltd reserve the right to refuse admission or change the site plan at its discretion and refuse any application for exhibition space. Disputes – Any discrepancies/grievances must be reported at the event – no correspondence will be entered into without this prior notice.

MATERIAL BREACH – In the event of a material breach of these conditions and no remedy being possible RN events Ltd shall be entitled to cancel the booking with no liability to RN events Ltd with no refund payable and to require the exhibitor to vacate the site. RN Events Ltd will be entitled to resell the stand and the exhibitor will indemnify RN Events Ltd for any losses incurred.

LIMITATION OF LIABILITY – All warranties, conditions and other terms implied by statute or common law are excluded to the fullest extent permitted by law. the event Organiser shall not be liable for loss of profits, loss of business, depletion of goodwill and/or similar losses, loss of goods or any special, indirect, consequential or pure economic loss, costs, damages, charges or expenses incurred by the exhibitor. the event Organiser's total liability in contract, tort (including negligence or breach of statutory duty), misrepresentation, restitution or otherwise arising in connection with the performance, or contemplated performance of their obligations under this Agreement shall be limited to the booking fee paid by the Exhibitor. The Exhibitor shall not be entitled to claim from the Event Organiser for any losses for which he is entitled to recover from his insurers (or would have been so entitled had he complied with his obligation to insure as stated above).

Nothing in these conditions limits or excludes the liability of the Event Organiser for death or personal injury resulting from negligence.

WHOLE AGREEMENT – These terms and conditions and the accompanying booking form constitute the whole agreement between the Event Organiser and the Exhibitor and supersede all previous agreements between them. The Exhibitor acknowledges that, in applying for exhibition space, it has not relied on, and shall have no right or remedy in respect of, any written or oral statement, representation, assurance or warranty (whether made negligently or innocently). Nothing in these conditions limits or excludes any liability for fraud or fraudulent misrepresentation.

ASSIGNMENT – the event Organiser reserves the right to assign the exhibitors' booking to any limited company incorporated for the purpose of trading for this event. The Exhibitor agrees to sign any letter of amendment to affect such assignment. The Exhibitor will not be entitled to assign its booking which is personal to it.

GOVERNING LAW – These terms and conditions, and any dispute or claim arising out of or in connection with them or their subject matter or formation (including noncontractual disputes or claims) shall be governed by, and construed in accordance with, the law of England and Wales.
